The Scholarship Committee of the Long Island Chapter of the Appraisal Institute is accepting applications for scholarships to be awarded for Year 2023. The scholarship fund was donated by James G. Taylor, MAI, SRA in memory of his wife Maureen Taylor.

Members must be in good standing with the Long Island Chapter of the Appraisal Institute for the 12 months before the application deadline to be eligible. Courses, seminars, and classes starting December 2023 can be applied to the scholarship total. Scholarship winners have two years (December 2023 – December 2025) to submit their paperwork, including evidence of course completion and tuition paid, and they will receive scholarship payment.

To apply for the award, one must complete an application and submit a letter that briefly describes your experience and intentions in the appraisal profession. Information must be included regarding applicant's appraisal education, employment history, involvement in the appraisal industry, in and out of the Chapter, and any other information that would support the application. Reference letters in support of your application are welcomed.
